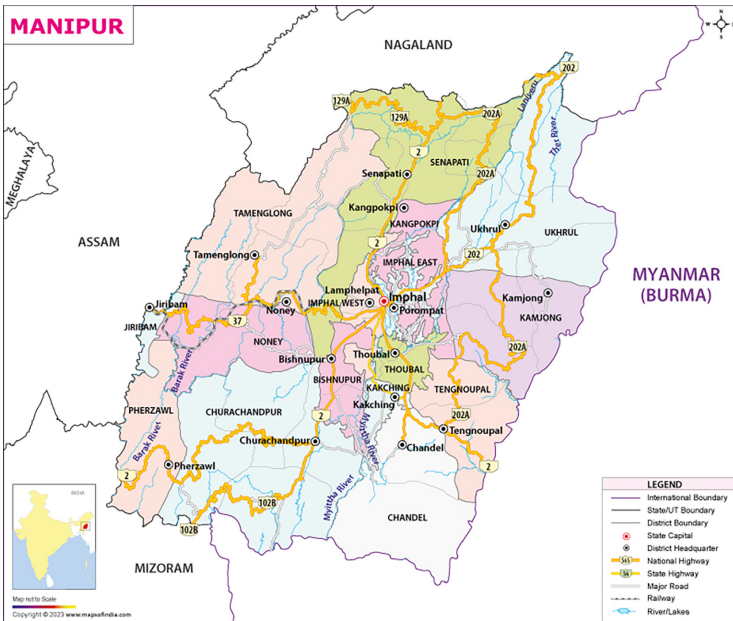

# KING CHILLI

Local Name: U-Morok

Botanical Name: *Capsicum annum*

King Chili (*U-Morok*) is a crop which has been cultivated in Manipur since time immemorial. King Chili is among one of the hottest chillies in the world reporting a Scoville Heat Unit (SHUs) of 20,41,427. It is consumed in fresh or dried form and used for its distinct flavour and aroma in the various culinary preparations. In recent years this crop is gaining importance because of its high content of capsaicin (3-5%) as compared to any other Indian chilli. There are several products which can be prepared from King Chilli such as whole dried, ground or powdered, pickles, sauce, chutney, oleoresin, essential oil, as ingredient in pepper spray, etc.

Local Name: Pineapple

Botanical Name: *Ananas comosus*

Variety: Kew & Queen

Pineapple is one of the most popular tropical fruits. It is a good source of Bromelain - a digestive enzyme and rich in Vitamins, Calcium, Magnesium, Potassium, Iron.

The pineapple varieties 'Kew' and 'queen' are extensively grown in Manipur. The fruits of Kew variety are big size, broad and shallow eyes, light yellow flesh, almost fibreless and very juicy and popular for its processing attributes. On the other hand, the fruits of queen variety are rich yellow in colour, less juicy than Kew, crisp textured with a pleasant aroma and flavour popular for table purpose. Queen' pineapple is available from June to August while 'Kew' is available from September to November every year.

## KIWIFRUIT

Local Name: Kiwifruit

Botanical Name: *Actinidia deliciosa*

Variety: Hayward

Kiwis are a nutrient dense food and low in calories. The fruit is known for presence of antioxidants, fibre, vitamins and immunity boosters. It is slightly acidic in taste. Raw kiwis are high in vitamins C and K. The black seeds inside the kiwifruit can be crushed to produce Kiwi fruit oil which is very rich in Alfa-Linoleic Acid, an important Omega-3 essential fatty acid. Kiwi fruits are useful in improving conditions of asthmatic children and in decreasing the probability of colon cancer by providing a good amount of dietary fibre. Kiwifruit ripens during September to December depending upon variety and climate. The berries are harvested when they are still hard and generally ready for harvest in between 125-150 days after fruit set.

Kachai Lemon of Manipur is an exotic horticultural fruit from Northeast India which has been accorded Geographical Indication (GI) registration tag owing to its unique taste and flavour. Popularly known as Kachai Champra (Lemon), it is widely grown in the Kachai village in Ukhrul District, Manipur. Unlike the other lemon varieties grown in other part of world, Kachai Lemon is considered to be unique as it is a rich source of ascorbic acid, containing 45-51 mg/100 ml juice. The juice content is 36-56 ml per fruit. The fruit will be available from January to March every year.

## TAMENGLONG ORANGE/ MANDARIN

Local Name: Tamenglong Orange

Botanical Name: *Citrus reticulata*

Variety: Local

Tamenglong orange / Mandarin (*Citrus reticulata*) is unique crop found only in the Tamenglong district of the state of Manipur which has bagged GI Tagged for its unique taste. The plant is perennial evergreen of the Rutaceae family and subtropical in distribution. Tamenglong oranges weight around 90-110 g. Fruit has loose skinned, smooth surface, approx. 10 segments, abundant juice (40-50 %) with well blended sweetness and acidity taste.

It is also full of vitamin C, which protects cells by neutralizing free radicals. The harvested fruit will be available from October to February every year.

## PASSION FRUIT

Local Name: Sitaphon

Botanical Name: *Passiflora indica*

Variety: Local (Yellow and Purple)

Passion fruit is the fruit of the *Passiflora* vine, a type of passion flower. Passion fruit is a nutritious tropical fruit that is gaining popularity, especially among health-conscious people. Despite its small size, it is rich in antioxidants, vitamins and plant compounds that could benefit. The fruit has two main forms: yellow (*P. edulis* flavicarpa) and purple passion fruit (*P. edulis* Sims). Its sowing time is June-July and after 16-18 months, passion fruit takes about 85-90 days from flowering to maturity.
